Consequent upon the approval by the Hon'ble Vice Chancellor to the recommendations of the Selection Committee and subject to the ratification by the Executive Council, sanction is hereby accorded to the appointment of **Dr. Sheikh Mohd Imran S/o Sheikh Riyaz Ahmad R/o Mughal Masjid, Hawal Srinagar (J&K)** bearing application Form No. 4220042 as **Librarian** under UR Category in the Academic Pay Level-14 with rationalized entry pay of Rs. 144200/- plus allowances as admissible under rules in the Rumi Library, (IUST).

The appointment shall be governed by the following terms and conditions:

1. The appointee shall have an initial tenure of three years, which may be further extended based on performance, & subject to the approval of Executive Council.
2. The appointee shall furnish an affidavit dully attested by Judicial Magistrate that he shall serve the university for a minimum period of three years from the date of his joining and shall not apply for any similar / equivalent position during the said period.
3. The appointee shall be on probation for a period of two years extendable by one more year from the date of joining on the post.
4. The service conditions of the appointee shall be governed by the University Statutes and rules as are in force with amendments or as may come into force with amendments, from time to time together read with provisions of J&K CSR wherever applicable.
5. The appointee shall be governed by New Pension Schemes (NPS) as per norms laid down by the J&K Government under SRO 400 of 2009 dated: 24-05-2009 with modifications, if any.
6. The appointee shall be required to execute a Service Contract (format enclosed) embodying the detailed terms and conditions on a non-judicial stamp paper of the value of Rs.100.
7. The appointee shall have to join within 15 days from the date of issuance of this order failing which the appointment shall be deemed to have been cancelled ab-initio without any further notice. Further, the joining of appointee shall be subject to the production of following certificates in original:
 - a) Certificates of Educational / Professional Qualification (Matriculation onwards).
 - b) Date of Birth Certificate.
 - c) Discharge / Relieving Certificate from the present employer (if applicable).
 - d) Clearance Certificate issued by the present employer stating that no Vigilance/ disciplinary proceedings are contemplated or pending against the appointee. (in case of in-service candidates).

- a) Medical Fitness Certificate issued by concerned Chief Medical Officer.
- b) NDC from the ARI, Trainings and Grievances Department, Govt. of UT of J&K in terms of the Circular No. 04-JK (ARI & Trags) of 2024 Dated: 14-03-2024.
- ii) If the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the University from his salary. Affidavit, attested by the First-Class Magistrate to this effect shall be submitted by the candidate regarding both relinquishments of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made by the University or otherwise. The recovery, if any shall be monitored by the office of the Finance Officer / DDO.
- iii) The appointee shall give an undertaking duly attested by the First-Class Magistrate in the shape of an affidavit to the effect that, if on verification, the certificate(s) produced by the appointee are proved to be fake or forged, initially or at any later stage of service, the appointment shall be cancelled ab-initio and the University shall reserve the right to initiate action as warranted under rules.
- iv) The appointee shall give an undertaking dully attested by the First Class Magistrate in the form of an affidavit to the effect that the publications submitted by him are free from plagiarism and in case any kind of plagiarism is found initially or at any stage of service, the appointment shall be cancelled ab-initio and the University shall reserve the right to initiate action as warranted under rules.
- v) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of qualifications / date of birth is received from the concerned authorities / institutions.
- vi) The appointment of the above candidate shall be subject to the outcome of writ petition (if any) pending in the Hon'ble Courts of J&K.

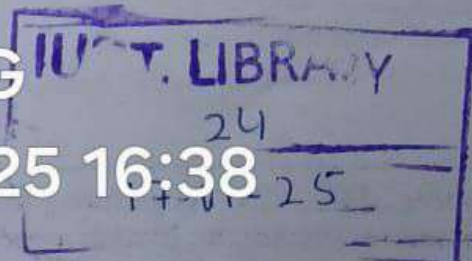
