Whereas, a written test was conducted on 04.05.2023, in which 69 candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/22 dated 05.06.2023 in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examinations) Rules, 2022 read with Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date and 10 candidates were called for interview; and,

Whereas, the viva-voce of candidates was conducted on 24.08.2023 with the assistance of Experts.
